 37 of the 2012 session, if any, shall be as specified by subsequent resolution of the General
 38 Assembly; provided that unless otherwise specified by subsequent resolution the General
 39 Assembly shall be in adjournment on each Saturday and Sunday.

40 BE IT FURTHER RESOLVED that, as authorized by Code Section 28-1-2, the hours for
 41 closing and convening the Senate on each day may be as ordered by the Senate; and the
 42 hours for closing and convening the House on each day may be as ordered by the House.
